Now in its 14th year, this seminar addresses more advanced areas of juvenile court practice. This year, we are featuring two presentations of great relevance. While the judiciary is required to maintain its neutrality and to function independently from public pressure, current events show that judges and their families are not immune from risk of harm or even death from those who disagree with their decisions. The same is true of attorneys who work in challenging legal environments where emotions can run high, such as juvenile court cases. We are honored to have John Muffler, MS, CTM, Principal with Aequitas Global Security, LLC, a nationally-recognized expert, who will address these realties and suggest strategies for increasing safety in the courtroom.

Juveniles often find themselves at risk of harm or prosecution resulting from their use of the internet or social media. Amie Konwinski, the founder and CEO of Smart Gen Society, will address the paradox that while social media appears to increase our "connectedness," it also has caused a decrease in "attention spans, empathy, and civil discourse while increasing major depressive disorders, self-harm and suicide rates among today's youth." Ms. Konwinski will present valuable strategies on how to transition away from the negative social media impact upon juveniles and our communities

During this last year, juvenile court case management returned to the Nebraska Department of Health and Human Services (NDHHS) after years of privatized case management. Representatives from NDHHS will present information regarding the transition and its current state. In addition, the seminar will feature an overview of the YRTC facilities.

This seminar is co-sponsored by Creighton University School of Law and the Guardian ad Litem Project, Inc., a Nebraska non-profit corporation. Lunch will be provided to those attending in person.

Judges

Hon. Vernon C.R. Daniels, a University of Nebraska College of Law graduate, has served as a judge of the Separate Juvenile Court of Douglas County, Nebraska, for 21 years. He is a former member of the Nebraska Supreme Court Commission on Children in the Courts as well as the Governor's Children's Task Force. He also served on the Supreme Court-Nebraska State Bar Association's Minority and Justice Task Force and Implementation Committee of that Task Force. He was a member of the Commission on Juvenile Diversion, Detention, and Probation Uniform Standards, as well as a board member for the Boy Scouts Diversion Program. Judge Daniels is currently a member of the steering committee of the "Building Bright Futures" initiative. He is an adjunct faculty member at Creighton University School of Law, where he teaches courses in "Offender Law," and "Children, Family and the State." He co-chairs the Juvenile Detention Alternatives Initiative for the Annie E. Casey Foundation for Douglas County. Judge Daniels enjoys mentoring new attorneys and law students. In 2021, he received the "Distinguished Judge Award" from the Nebraska Supreme Court.

Hon. Candice J. Novak is the current Presiding Judge of the Separate Juvenile Court of Douglas County. Prior to her judicial appointment in 2020, she was engaged in the practice of law in Omaha, focusing upon juvenile law. From 2006-2010, she was an associate attorney in a firm that contracted to handle guardian ad litem representation exclusively in juvenile cases in Douglas County. After that, she entered solo practice where she continued guardian ad litem representation in both Douglas and Sarpy counties, and also expanded her juvenile court practice to include representation of parents in abuse and neglect cases, adoptive parents, and also juveniles in delinquency cases. She also provided representation to parents, guardians, and wards in probate matters, as well as parents in criminal proceedings relative to juvenile court filings, and minors involved in misdemeanor matters and district court felony matters. Judge Novak previously served as the Nebraska State coordinator for the National Association for Counsel for Children, and also served on the legislative committee for the Juvenile Section of the Nebraska Bar Association. She assisted in the development of the Nebraska Juvenile Court Young Child Court Form as provided by the Through the Eyes of the Child Initiative. She is currently a member of the Guardian ad Litem Subcommittee of the Nebraska Supreme Court Commission on Children in the Courts.

Hon. Anne Paine holds a degree in English Education from Kearney State College in 1984, and her juris doctorate from the University of Nebraska College of Law in 1988. She practiced law from 1988-2007after she became a County Judge in the Eleventh Judicial District, based out of McCook. She currently serves in Red Willow, Furnas, Hitchcock, Hayes and Frontier Counties

and also handles conflict cases in other counties as needed in the Judicial District. Judge Paine is a member of the Nebraska Supreme Court Commission on Children in the Courts and the Judicial Resource Commission, and serves as lead judge for the 11th District Team 3 Through the Eyes of the Child Team.

Hon. Randin R. Roland graduated from Creighton School of Law in 1993, and afterward, engaged in private practice in South Dakota. From 1995-2006 he was employed in the Cheyenne County Attorney's office in Sidney, Nebraska, and served as its chief deputy from 2003-2006. He is presently the presiding judge of the county court of 12th Judicial District.

Hon. Mary "Peg" Stevens, J.D., has served as a judge of the Separate Juvenile Court of Douglas County, Nebraska, for nearly 3 years. She is a member of the Nebraska Supreme Court Commission on Children in the Courts and also a member of the Appellate Law and Juvenile Law sections of the NSBA. Prior to being appointed to the juvenile bench, Judge Stevens was a partner at Carlson & Burnett, LLP, where her primary legal practice focused upon juvenile law and trial advocacy, working to protect the legal rights of families and children impacted by domestic abuse and child abuse. Judge Stevens obtained her undergraduate degree in Criminal Justice, then her Juris Doctor degree from Creighton University School of Law in 1988. She was a Deputy County Attorney in the Sarpy County Attorney's Office for 10 years, during which time she handled a variety of juvenile and criminal cases ranging from misdemeanors to felonies. Since 2017, she has participated in the revision of the Nebraska Evidence Handbook.
